**Positive Profit Alert**

**The Group Expects A Turnaround from Loss to Profit of up to Approx. HK\$71.0 Million in 2025 An Operating Profit up to Approx. HK\$96.3 million, including An Operating Profit Attributable to the Shareholders up to Approx. HK\$41.6 million with respect to its Business Operations**

(Hong Kong, 10 March, 2026) **Town Health International Medical Group Limited** (“**Town Health**” or the “**Company**”, together with its subsidiaries, collectively the “**Group**”; Stock Code: 3886.HK) issues a positive profit alert announcement after trading hours today, for its annual results for the year ended 31 December 2025 (the “**Year**”).

Based on the information currently available, it is expected that during the Year, the Group will record a profit in the range of approximately HK\$45.2 million to HK\$71.0 million (2024: loss of approximately HK\$158.2 million), including a profit attributable to the shareholders in the range of approximately HK\$10.4 million to HK\$16.3 million (2024: loss attributable to the shareholders of approximately HK\$203.7 million).

This turnaround from loss to profit was mainly attributable to:

- (i) a decrease in fair value loss of the Group’s investment properties recorded for the Year as compared to last year;
- (ii) a decrease in impairment losses recognised on the Group’s interests in associates for the Year as compared to last year;
- (iii) a decrease in impairment losses recognised on the Group’s goodwill for the Year as compared to last year; and
- (iv) the recording of the Group’s share of profits of associates for the Year.

If the “other gains and losses, net” as shown in the consolidated statement of profit or loss are excluded, the Group expects an operating profit in the range from approximately HK\$61.3 million to HK\$96.3 million, including an operating profit attributable to the shareholders in the range from approximately HK\$26.5 million to HK\$41.6 million, with respect to its business operations would have been recorded for the Year.

The Company is still in the process of finalising the annual results of the Group for the Year. The figures and information contained in the announcement of positive profit alert have not yet been reviewed or audited by the Company’s auditors. The finalised annual results of the Group and other details will be disclosed in the annual results announcement for the Year to be published by the Company.
